Urgent Notice for amendments of entrance examination requirements for
October 2020 Entrance**

[Notice] Due to the current situation caused by the outbreak of Covid-19, it is presumed that some applicants have been unable to take the TOEIC or TOEFL examinations.

Thus, the following three amendments have been made to the October 2020 entrance examination for the Water and Environmental Engineering Program.

Please note that there are no amendments other than these three items.

1) On application procedures

Current requirements

The score sheet of “TOEIC® Listening & Reading Test”, or “TOEFL iBT®	The official score certificate is only valid if obtained within the past 3 years from the examination date (<u>Applicants without any of those official score certificates are not eligible for taking the entrance examination.</u>) The official score certificate will be returned enclosed along with the admission exam ticket. If any of the certificates listed on the left are not available in time, or if you are able to submit recently obtained certificates other than those submitted at time of application, please submit it to the Student Affairs Section by noon of the day before the examination.

After amendment

Applicants who have already obtained an official score certificate of either TOEIC® Listening & Reading Test (public test) or TOEFL iBT® must submit it. However, the official score certificate is only **valid if obtained within the past 3 years from the examination date.** The official score certificate will be returned enclosed along with the admission exam ticket.

For applicants who cannot obtain the TOEIC® Listening & Reading Test (public test) or TOEFL iBT®, there is no need to submit it.

2) Amendment on evaluation method

Current evaluation method for English proficiency

English proficiency will be evaluated based on the official score of any one of “TOEIC® Listening & Reading Test”, or “TOEFL iBT®” (allocation of 20 points).

After amendment

For English proficiency, one of the two following methods with the highest score will be used for the evaluation.

- 1) **English proficiency** will be evaluated based on the official score of any one of “**TOEIC®** Listening & Reading Test”, or “**TOEFL iBT®**” (allocation of 20 points). *Notice 1
- 2) **English proficiency** will be evaluated based on **the interview and the essay** (allocation of 20 points). *Notice 2

Evaluation method 2) will be applied for those who are unable to submit “TOEIC® Listening & Reading Test” or “TOEFL iBT®” scores.

Notice 2)

English proficiency for listening and speaking will be evaluated based on the scores **of the interview examination**. English composition and grammar will be evaluated based on the score of the English essay writing.
